What is this product? 本基金是什麼產品？

First Sentier Long Term Bond Fund (the “Fund”) is a sub-fund of First Sentier Investors Global Umbrella Fund plc (the “Company”). This is a mutual fund domiciled in Ireland and its home regulator is the Central Bank of Ireland. 首源長期債券基金 (「本基金」) 乃首源投資環球傘子基金有限公司 (「本公司」) 之子基金。本基金為以愛爾蘭為註冊地的互惠基金，其主要監管機構為愛爾蘭中央銀行。

Objectives and Investment Strategy 目標及投資策略

The investment objective of the Fund is to provide a total return greater than the FTSE US Government Bond 5+ years Index. 本基金的投資目標是提供比 FTSE 美國政府債券 (5 年期以上) 指數優厚的整體回報率。

The Fund invests at least 70% of its Net Asset Value in debt securities of governments or quasi-government organization issuers and/or issuers organised, headquartered or having their primary business operations in United States or in United States Dollar denominated debt securities (including up to 10% of its Net Asset Value in U.S. Dollar cash deposits). 本基金將至少 70% 的資產淨值投資於政府或半政府機構發行人及 / 或在美國成立、設立總部或經營主要業務的機構所發行的債務證券或美元計價債務證券 (包括最多達其資產淨值 10% 投資於美元現金存款)。

The Fund is not subject to any limitation on the portion of its Net Asset Value that may be invested in investment grade corporate and government debt securities (rated A3 or above by Moody’s Investor Services, Inc or A- or above by Standard and Poor’s Corporation, or other recognised ratings agencies) or, if unrated, of comparable quality as determined by the Investment Manager. The Fund’s investment in debt securities may include securities with loss-absorption features (including contingent convertible debt securities, senior non-preferred debt, instruments issued under the resolution regime for financial institutions and other capital instruments issued by banks or other financial institutions) which will be less than 30% of the Fund’s Net Asset Value. The Fund may also invest in asset-backed securities and/or mortgage-backed securities but any such investment will be less than 30% of its Net Asset Value. 本基金可用以投資於投資級別企業及政府債務證券 (獲穆迪投資者服務給予 A3 或以上評級或獲標準普爾或其他認可評級機構給予 A- 或以上評級) 的資產淨值部份並不受任何限制；或倘未經評級，則須獲投資經理認為質素相若。本基金對債務證券的投資可能包括具有損失吸收特點的證券 (包括或有可換股債務證券、高級非優先債務、金融機構處置機制下發行的工具以及銀行或其他金融機構發行的其他資本工具)。有關投資將少於本基金資產淨值的 30%。本基金亦可投資於資產擔保證券及 / 或按揭證能，但任何有關投資將少於其資產淨值的 30%。

The Fund is not subject to any limitation on the portion of its Net Asset Value that may be invested in debt securities in any sector.

本基金可用以投資於任何行業的債務證券的資產淨值部份並不受任何限制。

The Fund will hold securities from at least 6 different issues. The maximum investment in any non-government issuer rated Aa2 or above by Moody's Investor Services Inc, or AA or above by Standard and Poor's Corporation will be 10% of the net assets of the Fund. The maximum investment in any issuer rated below Aa2, but A3 or above by Moody's Investor Services Inc or below AA but A- or above by Standard and Poor's Corporation will be 5% of the Fund's net assets. The Fund will not hold more than 10% of the total issue of any non-governmental security. 本基金將至少持有六種不同證券。本基金對任何一間獲穆迪投資者服務給予 Aa2 或以上評級或獲標準普爾給予 AA 或以上評級的非政府發行機構所發行證券的投資乃以淨資產的 10% 為限。對任何一間獲穆迪投資者服務給予 Aa2 以下但達到 A3 或以上評級、獲標準普爾給予 AA 以下但達到 A-或以上評級的發行機構的投資則以基金淨資產 5% 為限。本基金所持有任何非政府證券亦不得超過該種證券總發行量的 10%。

The Fund will not invest more than 10% of its Net Asset Value in debt securities issued by and/or guaranteed by a single sovereign issuer which is below investment grade. 本基金不會將其超過 10% 的資產淨值投資於低於投資級別的單一主權發行機構所發行及 / 或提供擔保的債務證券。

The Fund may invest less than 30% of its Net Asset Value in onshore debt securities in the PRC via Bond Connect.

本基金可將其少於 30% 的資產淨值透過債券通投資於中國在岸債務證券。

The Fund may only use financial derivative instruments ("FDIs") for purposes of hedging and efficient portfolio management. It is not intended that the Fund will avail of the opportunity to invest in FDIs for investment purposes. 本基金僅可為進行對沖及有效管理投資組合而使用金融衍生工具 (「金融衍生工具」)。本基金不擬就投資目的而藉機投資於金融衍生工具。

Benchmark information: 基準資料：

The Fund's investment objective is to provide a total return greater than the FTSE US Government Bond 5+ years Index. The Fund is actively managed meaning that the Investment Manager uses its expertise to pick investments rather than tracking the allocation and therefore the performance of the benchmark. The Fund's performance is compared against the value of the following benchmark: FTSE US Government Bond 5+ years Index. Please refer to the Fund's investment policy in the Prospectus for details of the benchmark information. 本基金的投資目標是提供比 FTSE 美國政府債券 (5 年期以上) 指數優厚的整體回報率。本基金是主動型管理基金，意指投資經理運用其專業知識挑選投資，而非追蹤基準的配置以及其表現。本基金的表現與以下基準的數值作比較：FTSE 美國政府債券 (5 年期以上) 指數。請參閱章程所載本基金的投資政策，了解有關基準資料的詳情。

- **Investment Risk** – The value of the Fund's investment portfolio may fall due to any of the key risk factors below and therefore your investment in the Fund may suffer losses. There is no guarantee of the repayment of principal.

- **Single Country/Specific Region Risk** – The Fund's investments may be concentrated in a single country or a small number of countries or a specific region. The value of the Fund may be more volatile than a fund having a more diversified portfolio of investments covering multiple countries. The value of the Fund may be more susceptible to an adverse economic, political, policy, foreign exchange, liquidity, tax, legal or regulatory event affecting the relevant market.

The Fund may have limited legal recourse if the debtor defaults and the Fund may suffer loss as a result.

These securities are generally subject to higher volatility and greater risk of loss of principal and interest than high-rated debt securities. Settlement of transactions may be subject to delay and administrative uncertainties. The market for these securities may be illiquid and the Fund may not be able to acquire or dispose of such securities quickly.

FDIs that are not traded on an exchange are subject to, among others, liquidity risk (i.e. the risk that the Fund may not be able to close out a derivative position in a timely manner and/or at a reasonable price), counterparty risks (i.e. the risk that a counterparty may become insolvent and therefore unable to meet its obligations under a transaction), valuation risk, volatility risk and over-the-counter transaction risk. The leverage component of an FDI can result in loss significantly greater than the amount invested in the FDI by the Fund. In adverse situations, the use of FDIs may become ineffective in achieving hedging or efficient portfolio

management and may lead to a high risk of significant losses by the Fund.

The Fund may create currency hedged share classes to hedge the resulting currency exposure back into the currency of the relevant class. In addition the Fund may invest in assets with various currency denominations other than the base currency, and the Fund may hedge currency exposure due to investing in assets denominated in currencies other than the Fund's base currency.

Whilst these hedging strategies aim to reduce the losses to an investor's investment if the currency of that currency hedged share class or the currencies of the underlying assets which are denominated in currencies other than the Fund's base currency fall against that of the base currency of the Fund the use of hedging strategies may substantially limit investor in the relevant class from benefiting if the currency of that currency hedged share class rises against that of the base currency of the Fund and/or the currency in which the assets of the Fund are denominated.

Investors should be aware that there may be circumstances in which a hedging transaction may reduce currency gains that would otherwise arise in the valuation of the Fund. The gains/losses on, and the costs of, such hedging transactions will, to the extent permitted by applicable law and regulation, be borne on a pro rata basis by the currency hedged share classes.

Investors in currency hedged share classes should be aware that the currency hedging process for both types of currency hedged share classes may not give a precise hedge. Hedging transactions are designed to reduce, as much as possible, the currency risk for investors. However, there is no guarantee that the hedging will be totally successful and no hedging strategy can eliminate currency risk entirely. Should a hedging strategy be incomplete or unsuccessful, the value of the Fund's assets and income can remain vulnerable to fluctuations in currency exchange rate movements.

Investors in the currency hedged share classes may have exposure to currencies other than the currency of their share class and may also be exposed to the risks associated with the instruments used in the hedging process.
