Objectives and investment strategy

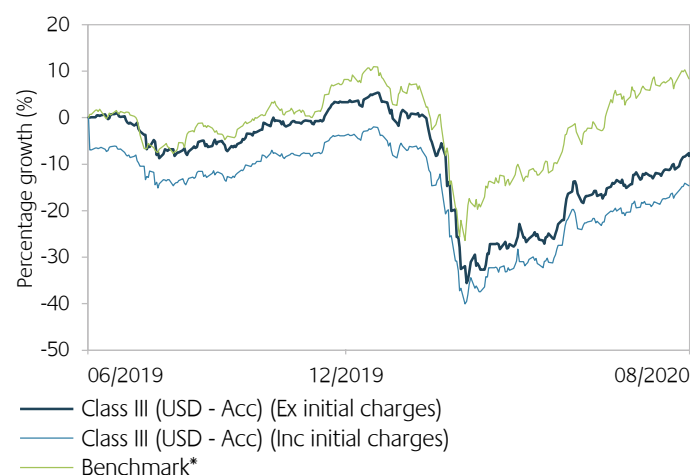
