## Objectives and investment strategy

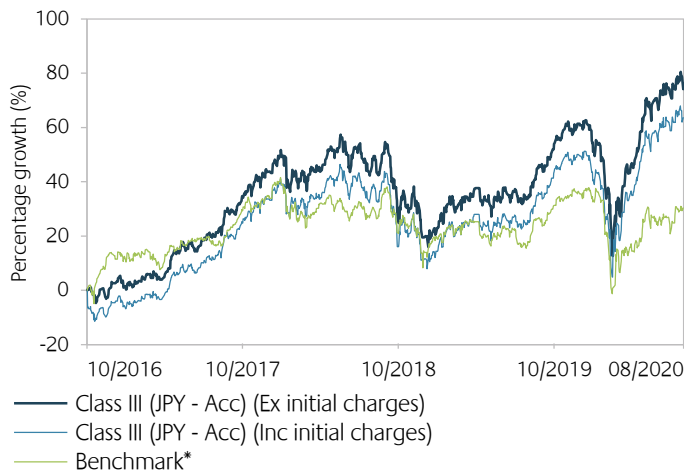
