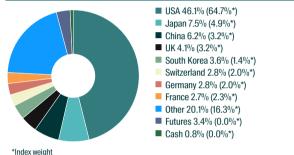

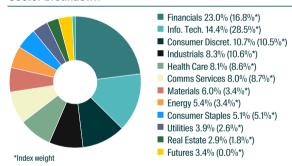
Cumulative performance in USD (%)
