Objectives and investment strategy

The Fund aims to achieve long term capital appreciation and invests all or substantially all of its assets in the Stewart Investors Worldwide Leaders Sustainability Fund (the "Underlying Sub-Fund"), under the Dublin registered First Sentier Investors Global Umbrella Fund plc. The Underlying Sub-Fund invests primarily (at least 70% of its net asset value) in a diverse portfolio of equity securities or equity-related securities of larger capitalisation companies which are listed, traded or dealt in on any of the regulated markets worldwide. The Underlying Sub-Fund will not invest in securities of small capitalisation companies. The Underlying Sub-Fund invests primarily (at least 90% of its Net Asset Value) in companies it believes contribute to, and benefit from, sustainable development. ▲


