Investment objective and policy

The Fund aims to grow your investment. The Fund invests at least 70% of its assets in shares of large and mid sized companies that are based in, or closely associated with, mainland China. These companies generally have a total stock market value of at least US \$1 billion. The Fund may invest up to 100% of its assets in any industry. The Fund will not invest more than 100% of its assets in China A Shares. The Fund may use derivatives with the aim of risk reduction or efficient management.

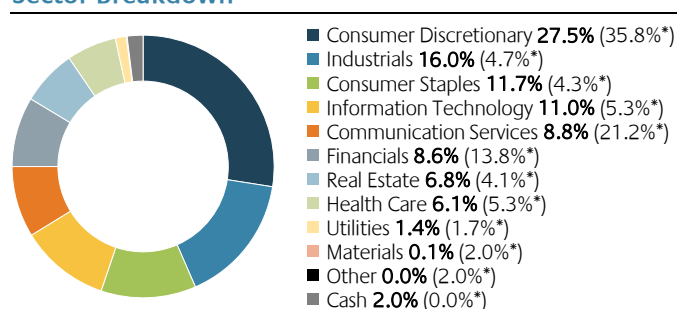

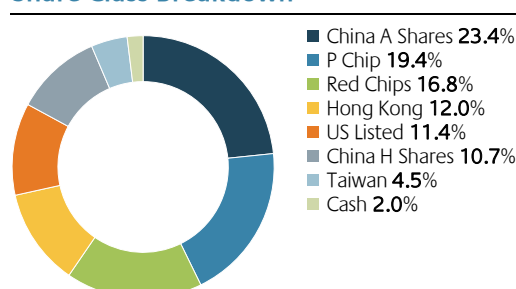

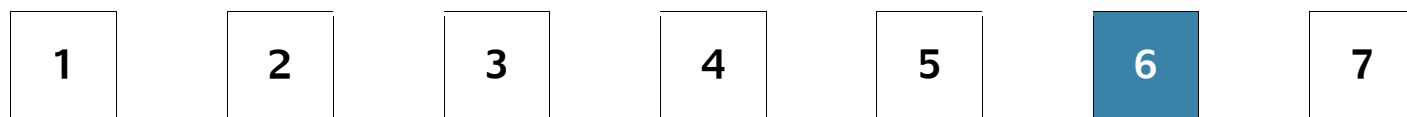
