The Fund may use derivatives with the aim of risk reduction or efficient management.

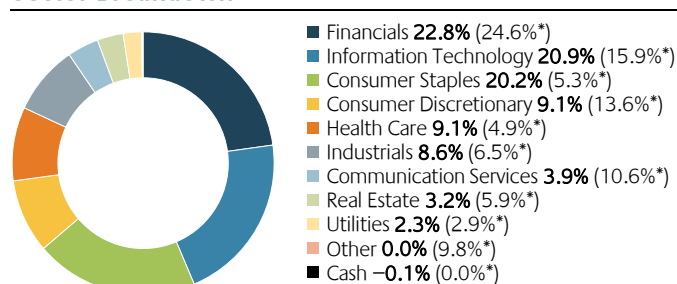

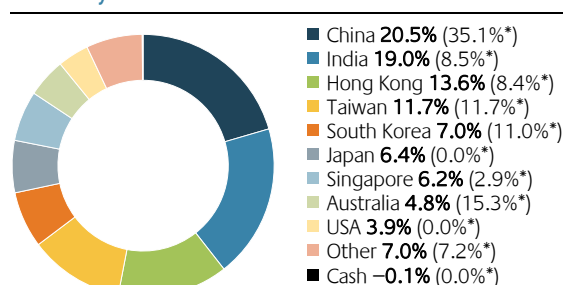
